Rules and Regulations

NO GENERATORS

Attention Food Vendors:

MENUS MUST BE PRE-APPROVED PRIOR TO SIGN UP TO AVOID DUPLICATION.

Hand Washing stations will be required at each food booth. Food trailers are required to have their state issued permit and scorecard on display.

A copy of your health inspection card must be provided with the vendor application.

Churches, schools and non-civic groups are not required to have a permit.

1. Show space will be available to businesses/companies/organizations (local, state, and federal). Booths are to be reserved in your name only, no shared booth applications will be accepted. To ensure high quality of exhibits, the festival committee reserves the right to ask exhibitors to remove any items they determine unsuitable from displays. Food vendors may be limited.
2. Set-up begins Friday, October 16th, 2026 from 9 AM - 5 PM, Saturday, October 17th, 2026 from 7:30 AM to 9 AM, & Sunday, October 18th 2026 from 7:30 AM to 9 AM. All exhibitors are expected to set up before festival hours. (10 AM - 5 PM on Saturday, October 17th, 2026 & 10 AM - 5 PM on Sunday, October 18th, 2026) and remain open until closing time. No vehicles will be allowed in exhibit areas between 9 AM - 5 PM on Sat. & Sun. Only emergency vehicles are authorized to be on property during these times.
3. **All exhibitors must bring tent, tables, 12-gauge 50 ft. extension cord for access to power (must indicate on previous page), etc. for set-up.** The space provided may or may not be on pavement. The festival is providing space and limited power. Access to power must be requested on the festival application.
4. Sales tax collection and payment to the State of Georgia is the exhibitor's responsibility.
5. All exhibitors are responsible for the clean-up of their space.
6. I give permission to the Black Bear Festival and the Murray County Chamber of Commerce to use photography or videography of me, as well as, my booth and all items made or displayed during the Black Bear Festival. Photography or videography may be used in print materials, on the Black Bear Festival website, and the Murray County Chamber of Commerce website, press release, or other social media sites.
7. **Cancellations prior to 10/01 will receive a refund less a \$35 cancellation fee. No refunds will be given after 10/01.**

HOLD HARMLESS AGREEMENT
